**Waiver, Indemnity and Hold Harmless Agreement  
Newcomers and Neighbors Club of Northern Nevada**

**Waiver:** It is expressly agreed that participation in Newcomers Club activities, including any transportation provided by a Club member, shall be undertaken at the undersigned’s sole risk, and the Club shall not be liable for any injuries or any damage to the member, or the property of the undersigned, or be subject to any claim, demand, injury or damages whatsoever, including without limitation, those damages resulting from acts of active or passive negligence on the part of the Club, its officers or agents.

The undersigned releases and discharges for himself/herself and on behalf of his/her executors, administrators, heirs, assigns and successors from all such claims, demands, injuries, damages, actions or causes of action. The Club shall not be responsible or liable for articles damaged, lost or stolen at any Club function, or for loss or damages to property including but not limited to automobiles and the contents thereof.

**Indemnify and Hold Harmless:** The undersigned agrees to indemnify and hold harmless the Newcomers and Neighbors Club of Northern Nevada for any occurrence caused, in whole or in part, by the undersigned and/or his/her guest at an event or activity sponsored by the Newcomers Club.

An Incident/Accident Report must be filled out and submitted to the Newcomers Board within 30 days of occurrence of incident/accident.

**Severable Provisions:** In the event that any part of this agreement is held to be void or unenforceable, that portion is severed, and the remainder of this agreement shall remain in force and effect.
